

**STATISTICAL REPORT FOR THE
FISCAL YEAR OCTOBER 1, 2013 - SEPTEMBER 30, 2014**

During the fiscal year, October 1, 2013 to September 30, 2014, the Court of Federal Claims disposed of 703 complaints (including Congressional Reference) and 562 vaccine petitions. Except for a number of these cases, in which no given amounts were claimed, the total amount claimed was \$ 5,534,021,000.00. Of the cases disposed of, the court rendered judgments for claimants in the sum of \$ 935,532,911.22 (annuity amounts are included in this figure) of which \$ 233,280,704.55 carried interest. A number of these judgments were based on settlements between the parties. Also the Court of Federal Claims rendered judgments for the United States on counterclaims or offsets in the amount of \$ 26,248,136.44, of which none carried interest. Under its non-monetary jurisdiction, the court disposed of 100 contract cases seeking injunctive or declaratory relief. Each January, pursuant to 28 U.S.C. § 791(c), the Clerk transmits to the Congress a report of the business of the Court of Federal Claims showing the names of the claimants, nature of the claim, and the disposition thereof.
