

**STATISTICAL REPORT FOR THE
FISCAL YEAR OCTOBER 1, 2021 - SEPTEMBER 30, 2022**

During the fiscal year, October 1, 2021, to September 30, 2022, the Court of Federal Claims disposed of 627 complaints and 1,231 vaccine petitions. Except for a number of these cases in which no given amounts were claimed, the total amount claimed was \$14,402,993,000.00. Of the cases disposed, the court rendered judgments for claimants in the sum of \$982,693,348.92 (annuity amounts are included in this figure if available) of which \$4,362,581.57 carried interest. A number of these judgments were based on settlements between parties. The Court of Federal Claims rendered money judgments for the United States on counterclaims, offsets and/or sanctions in the sum of \$200,526.96. Under its non-monetary jurisdiction (bid protest jurisdiction), there were 123 cases filed and the court disposed of 125.

Case filings increased in fiscal year 2022 for general jurisdiction cases and decreased for vaccine injury compensation cases. General¹ jurisdiction cases increased by 19.5% while vaccine petitions decreased by 50%. There were 107 general jurisdiction cases, approximately 13.1%, with multiple plaintiffs and 9.2% involved intervening parties.

Total case terminations increased 10.7% from 1,679 in fiscal year 2021 to 1,858 in fiscal year 2022. Pending cases at the close of the fiscal year increased 3.7% from 5,399 on September 30, 2021, to 5,600 on September 30, 2022.
