STIPULATED ATTORNEYS' FEES AND COSTS DECISION¹

On January 02, 2003, petitioners filed a claim for compensation on behalf of their son, Jack, in the National Vaccine Injury Compensation Program ("the Program"). The undersigned issued a decision in this case on March 28, 2011.

On May 10, 2011, counsel for both parties filed a stipulation. The parties stipulated that petitioners' counsel should receive a lump sum of \$3,328.16, in the form of a check payable to petitioners and the law firm of petitioners' attorney, Rawls & McNelis, P.C., for attorneys' fees and costs.² This amount represents a sum to which

respondent does not object.

The undersigned approves the requested amount for attorneys' fees and costs as reasonable. Accordingly, an award should be made in the form of a check payable jointly to petitioners and the Rawls & McNelis, P.C. law firm, in the amount of \$3,328.16. In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³
