ATTORNEYS' FEES AND COSTS DECISION¹

On May 04, 2004, petitioner filed a claim for compensation on behalf of her son, Carson, in the National Vaccine Injury Compensation Program ("the Program"). The undersigned issued a decision in this case on September 9, 2011.

On October 18, 2011, respondent file a stipulation of facts concerning attorneys' fees and costs. Petitioner is entitled to reasonable attorneys' fees and costs pursuant to §§ 15(b) and (e)(1). Petitioner seeks attorneys' fees and costs in the amount of \$1,697.52, in the form of a check payable to petitioner and petitioner's attorney, Scott W. Rooney.² This amount represents a sum to which respondent does not object.

As provided by Vaccine Rule 18(b), each party has 14 days within which to request redaction "of any information furnished by that party: (1) that is a trade secret or commercial or financial in substance and is privileged or confidential; or (2) that includes medical files or similar files, the disclosure of which would constitute a clearly unwarranted invasion of privacy." Vaccine Rule 18(b). Otherwise, "the entire" decision will be available to the public. Id.

The undersigned approves the requested amount for attorney's fees and costs as reasonable. Accordingly, an award should be made in the form of a check payable jointly to petitioner and petitioner's attorney, Scott W. Rooney, Nemes, Rooney and McKindles in the amount of \$1,697.52.³ In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.⁴

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See generally Beck v. Sec'y of Dep't Health and Human Services, 924 F.2d 1029 (Fed. Cir.1991).

⁴ Pursuant to Vaccine Rule 11(a), entry of judgment is expedited by the parties' joint filing of notice renouncing the right to seek review.
