## ATTORNEYS' FEES AND COSTS DECISION<sup>1</sup>

On May 04, 2004, petitioner filed a claim for compensation on behalf of her son, Carson, in the National Vaccine Injury Compensation Program ("the Program"). The undersigned issued a decision in this case on September 9, 2011.

On October 18, 2011, respondent file a stipulation of facts concerning attorneys' fees and costs. Petitioner is entitled to reasonable attorneys' fees and costs pursuant to §§ 15(b) and (e)(1). Petitioner seeks attorneys' fees and costs in the amount of \$1,697.52, in the form of a check payable to petitioner and petitioner's attorney, Scott W. Rooney.<sup>2</sup> This amount represents a sum to which respondent does not object.

The undersigned approves the requested amount for attorney's fees and costs as reasonable. Accordingly, an award should be made in the form of a check payable jointly to petitioner and petitioner's attorney, Scott W. Rooney, Nemes, Rooney and McKindles in the amount of \$1,697.52. In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.<sup>4</sup>
