DECISION¹

CAMPBELL-SMITH, Chief Special Master.

The parties filed a Joint Stipulation of Facts Concerning Attorneys' Fees and Costs (Stipulation) on June 24, 2011. The parties' Stipulation indicated Petitioners submitted a draft Application for Attorney's Fees and Costs (Draft Application) to respondent on or about June 06, 2011. The parties' Stipulation further indicated that in compliance with General Order #9, petitioners' counsel represents that petitioners have not incurred any out-of-pocket expenses in proceeding on the petition in this case. Respondent's counsel indicated she had no objection to petitioners' request for attorneys' fees and other litigation costs.

If, upon review, I agree that the identified material fits within the requirements of that provision, I will delete such material from public access.

After reviewing the request, the court awards **\$4,500.00** in attorneys' fees and other litigation costs, which shall be made payable jointly to petitioners and petitioners' counsel, David L. Terzian. The court thanks the parties for their cooperative efforts in resolving this matter. The Clerk shall enter judgment accordingly.²
