ATTORNEYS' FEES AND COSTS DECISION¹

On August 18, 2010, Mary Chervanick (petitioner), filed a petition pursuant to the National Vaccine Injury Compensation Program.² 42 U.S.C. §§ 300aa-1 to -34 (2006). Petitioner alleged that, beginning in August 2007, she began suffering from joint pain, fatigue, hair loss, weight loss, and mouth sores. Petitioner also alleged that beginning in October 2007, she began to experience persistent joint and muscle pain and a low grade fever. Petitioner contended that her symptoms and conditions result from her receipt of the human papillomavirus

vaccine (HPV) on August 27, 2007, October 31, 2007, and February 20, 2008. On May 3, 2013, a decision awarding compensation to petitioner based on the parties' stipulation was entered.

On December 3, 2013, petitioner filed a Stipulation of Facts Regarding Attorneys' Fees and Costs. According to the stipulation, the parties stipulate to an award to petitioner of attorneys' fees and costs in the amount of \$62,000.00. In accordance with General Order #9, petitioner's counsel represents that petitioner has not incurred any out-of-pocket expenses in pursuing her petition.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of the parties' stipulation, the undersigned **GRANTS** the request for approval and payment of attorneys' fees and costs.

Accordingly, an award should be made as follows:

in the form of a check jointly payable to petitioner and Mr. Lawrence R. Cohan of the law firm of Anapol Schwartz in the amount of <u>**\$62,000.00**</u>.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³

IT IS SO ORDERED.
