DECISION¹ (ATTORNEY FEES AND COSTS)

In this case under the National Vaccine Injury Compensation Program,² I issued a decision on July 11, 2011, dismissing this case. On August 5, 2011, petitioners filed a Motion for attorneys' fees and costs in this matter. That Motion requests a total payment of \$4,686.69, representing all attorneys' fees and costs. Petitioners represent that respondent does not oppose the amount requested. In lieu of filing a Vaccine General Order 9 statement, petitioners' counsel agrees to reimburse petitioners any costs that petitioners personally incurred that are compensable under § 15(e)(1).

Vaccine Rule 18(b). Otherwise, "the entire" decision will be available to the public. Id.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. § 300aa-15(b) and (e)(1). Further, the proposed amount seems reasonable and appropriate. Accordingly, I hereby award the total of \$4,686.89 as a lump sum, in the form of a check payable jointly to petitioners, Melanie Davis and Scott Davis, and petitioners' counsel, Shawn Khorrami.

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the clerk of the court shall enter judgment in accordance herewith.
