### DECISION ON FEES AND COSTS<sup>1</sup>

**LORD**, Special Master.

On April 5, 2012, the parties in the above-captioned case filed a Stipulation of Fact regarding final attorneys' fees and costs in this case. After informal discussions with Respondent, Petitioners request a total award of \$16,065.70 in attorneys' fees and costs. In accordance with General Order #9, Petitioners' counsel represents that Petitioners incurred no reimbursable personal litigation costs. Respondent does not object to this request. Id.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300aa-15(e). After reviewing the request, the undersigned finds the stipulated amount of \$16,065.70 in attorneys' fees and costs to be reasonable. Based on the request's reasonableness, the undersigned **GRANTS** the parties' request as outlined in the Stipulation of Fact.

Accordingly, pursuant to Vaccine Rule 13, Petitioners are awarded a total of **\$16,065.70** in attorneys' fees and costs. The judgment shall reflect that Petitioners are awarded fees and costs as follows:

**A lump sum of \$16,065.70 in the form of a check payable jointly to Petitioners, Renisha Bivins and Sheldon Bivins, and Petitioners' counsel,**
