### **DECISION ON FEES AND COSTS**<sup>1</sup>

**LORD**, Special Master.

On March 20, 2012, the parties in the above-captioned case filed a Stipulation of Fact regarding final attorneys' fees and costs in this case. After informal discussions with Respondent, Petitioner requests a total award of \$54,000.00 in attorneys' fees and costs. In accordance with General Order #9, Petitioner's counsel represents that Petitioner incurred no reimbursable personal litigation costs. Respondent does not object to this request. Id.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300aa-15(e). After reviewing the request, the undersigned finds the stipulated amount of \$54,000.00 in attorneys' fees and costs to be reasonable. Based on the request's reasonableness, the undersigned **GRANTS** the parties' request as outlined in the Stipulation of Fact.

Accordingly, pursuant to Vaccine Rule 13, Petitioner is awarded a total of **\$54,000.00** in attorneys' fees and costs. The judgment shall reflect that Petitioner is awarded fees and costs as follows:

**A lump sum of \$54,000.00 in the form of a check payable jointly to Petitioner and Petitioner's counsel, Mark T. Sadaka, Law Offices of Sadaka Associates, LLC, Englewood, NJ, for attorneys' fees and costs available under 42 U.S.C. § 300aa-15(e).**

The Court thanks the parties for their cooperative efforts in resolving this matter. In the absence of a motion for review filed pursuant to RCFC, Appendix B, the Clerk is directed to enter judgment accordingly.<sup>2</sup>
