## DECISION ON FEES AND COSTS<sup>1</sup>

LORD, Special Master.

On December 9, 2011, the parties in the above-captioned case filed a Stipulation memorializing their agreement as to the appropriate amount of attorneys' fees and costs in this case. After informal discussions with Respondent, Petitioner requests a total award of \$75,795.81 in attorneys' fees and costs. In accordance with General Order #9, Petitioner's counsel represents that Petitioner incurred no personal litigation costs. Respondent does not object to this request. <u>Id</u>.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300aa-15(e). After reviewing the request, the Court finds the stipulated amount of \$75,795.81 in attorneys' fees and costs to be reasonable. Based on the request's reasonableness, the undersigned **<u>GRANTS</u>** the parties' request as outlined in the Stipulation.

Accordingly, pursuant to Vaccine Rule 13, Petitioner is awarded a total of **\$75,795.81** in attorneys' fees and costs. The judgment shall reflect that Petitioner is awarded attorneys' fees and costs as follows:

(1) a lump sum of \$75,795.81 in the form of a check payable jointly to Petitioner and Petitioner's counsel, Firooz T. Namei, McKinney & Namei Company, L.P.A., for attorneys' fees and costs available under 42 U.S.C. § 300aa-15(e).

The Court thanks the parties for their cooperative efforts in resolving this matter. In the absence of a motion for review filed pursuant to RCFC, Appendix B, the Clerk is directed to enter judgment accordingly.<sup>2</sup>
