### **DECISION AWARDING ATTORNEYS' FEES AND COSTS<sup>1</sup>**

On September 30, 2011, the parties filed a stipulation, in which they agreed to settle the attorneys' fees and costs in this case. Petitioner requests \$95,000.00 for attorneys' fees and \$10,670.17 for attorneys' costs.

Pursuant to General Order #9, petitioner's counsel represents that petitioner did not incur any expenses to pursue the petition in this case.

Vaccine Rule 18(b) states that all decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would constitute a clearly unwarranted invasion of privacy. When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

The court finds the amounts to be reasonable and hereby adopts the parties' stipulation and awards compensation in the amount and on the terms set forth therein. Pursuant to the stipulation, the court awards **\$105,670.16**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of one check made jointly payable to petitioner and The Hart Law Firm in the amount of **\$105.670.16**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.<sup>2</sup>
