### **DECISION AWARDING ATTORNEYS' FEES AND COSTS<sup>1</sup>**

On September 24, 2013, the parties filed a stipulation of facts in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

L. No. 107-347, 116 Stat. 2899, 2913 (Dec. 17, 2002). Vaccine Rule 18(b) states that all decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would constitute a clearly unwarranted invasion of privacy. When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

In accordance with the General Order #9 requirement, petitioner's counsel asserts that petitioner incurred \$740.00 in out-of-pocket litigation expenses.

On August 28, 2013, petitioner submitted an application for attorneys' fees and costs to respondent, requesting \$8,873.37 in attorneys' fees and costs. Respondent does not object to this amount.

The undersigned finds this amount to be reasonable. Accordingly, the court awards:

- a. **\$8,873.37**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to Michael Nikolajuk, as the guardian/conservator of Kristin's estate, and Nemes Rooney, P.C., in the amount of **\$8,873.37**.
- b. **\$740.00**, representing reimbursement for petitioner's out-of-pocket litigation costs. The award shall be in the form of a check payable to Michael Nikolajuk, as the guardian/conservator of Kristin's estate, in the amount of **\$740.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.<sup>2</sup>

**IT IS SO ORDERED.**
