**UNPUBLISHED DECISION ON FEES AND COSTS<sup>1</sup>**

Petitioner Lorenzo E. Dominguez filed an initial application for attorneys' fees and costs on February 14, 2011. After discussions between the parties, Mr. Dominguez filed his amended application for fees and costs on February 24, 2011. The Court awards the amount to which respondent has not objected.

Mr. Dominguez claimed that the tetanus diphtheria vaccine caused an adverse reaction and received compensation based upon the parties' stipulation. Decision, filed February 25, 2011. Because Mr. Dominguez received compensation, he is entitled to an award of attorneys' fees and costs. 42 U.S.C. § 300aa-15(e).

All decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would clearly be an unwarranted invasion of privacy. When such a decision or designated substantive order is filed, the person submitting the information has 14 days to identify and to move to delete such information before the document's disclosure. If the special master agrees that the identified material fits within the categories listed above, the special master shall redact such material from public access. 42 U.S.C. § 300aa-12(d)(4)(B); Vaccine Rule 18(b).

Mr. Dominguez seeks a total of **\$21,704.73** in attorneys' fees and costs for petitioner's counsel. Additionally, Mr. Dominguez filed a statement of costs in compliance with General Order No. 9, stating that he incurred no litigation expenses while pursuing this claim. Respondent stated that she had no objection to this application for attorneys' fees and costs.

After reviewing the request, the court awards a check made payable to petitioner's attorney in the amount of **\$21,704.73** for attorneys' fees and other litigation costs. The court thanks the parties for their cooperative efforts in resolving this matter.

The Clerk shall enter judgment accordingly.<sup>2</sup>
