Petitioner, William Hobbs, filed an application for attorneys' fees and costs on October 26, 2009. Mr. Hobbs's statement pursuant to General Order No. 9 was not filed until December 15, 2009. Mr. Hobbs is awarded the amount to which respondent has not objected.

Mr. Hobbs has requested a total of \$10,216.00 in attorneys' fees and \$836.83 in costs for a total of **\$11,052.83**. Additionally, Mr. Hobbs filed a statement of fees and costs in compliance with General Order No. 9 on December 15, 2009, stating that he incurred no litigation costs. Respondent notified the court that she has no objections to this request.

All decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would clearly be an unwarranted invasion of privacy. When such a decision or designated substantive order is filed, the person submitting the information has 14 days to identify and to move to delete such information before the document's disclosure. If the special master agrees that the identified material fits within the categories listed above, the special master shall redact such material from public access. 42 U.S.C. § 300aa-12(d)(4)(B); Vaccine Rule 18(b).

After reviewing the request, the undersigned finds the requested amounts reasonable. Thus, petitioner is awarded attorneys' fees and other litigation costs. Those fees and costs are awarded as follows:

**A lump sum of \$11,052.83 in the form of a check payable to petitioner and petitioner's attorneys, Maglio Christopher & Toale.**

The court thanks the parties for their cooperative efforts in resolving this matter.

The Clerk shall enter judgment accordingly.<sup>2</sup>
