Petitioners' Motion for a Decision
Dismissing their Petition;
Insufficient Proof of Causation;
Vaccine Act Entitlement, Denial
Without Hearing

DECISION¹

On January 24, 2007, petitioners filed a Petition for Vaccine Compensation in the National Vaccine Injury Compensation Program [“the Program”],² on behalf of Hridhay R. Bashyam [“Hridhay”]. In effect, the petition alleges that various vaccinations injured Hridhay, and requested the case be placed in the Omnibus Autism Proceeding. The information in the record, however, does not show entitlement to an award under the Program.

On March 4, 2011, petitioners filed a Motion for a Ruling on the Record as it now stands. On March 11, 2011, petitioners filed a Motion to Withdraw that Motion, and substitute a Motion for a Decision Dismissing their Petition. Petitioners' Motion to Withdraw the Motion for a Ruling on the Record is **GRANTED**.

Further, consistent with the rule requirement, a motion for redaction must include a proposed redacted decision. If, upon review, I agree that the identified material fits within the requirements of that provision, I will delete such material from public access.

Petitioners assert in the Motion for a Decision Dismissing their Petition that under the current applicable law they will be unable to demonstrate entitlement to compensation in the Program. Petitioners' Motion, filed March 11, 2011, at 1. Accordingly, petitioners request that I dismiss the above-captioned petition. Id.

To receive compensation under the Program, petitioners must prove either 1) that Hridhay suffered a "Table Injury" – i.e., an injury falling within the Vaccine Injury Table – corresponding to one of his vaccinations, or 2) that Hridhay suffered an injury that was actually caused by a vaccine. See §§ 300aa-13(a)(1)(A) and 300aa-11(c)(1). An examination of the record did not uncover any evidence that Hridhay suffered a "Table Injury." Further, the record does not contain a medical expert's opinion or any other persuasive evidence indicating that Hridhay's alleged injury was vaccine-caused.

Under the Act, petitioners may not be given a Program award based solely on the petitioners' claims alone. Rather, the petition must be supported by either medical records or by the opinion of a competent physician. § 300aa-13(a)(1). In this case, because the medical records supporting petitioners' claim are insufficient, a medical opinion must be offered in support. Petitioners, however, have offered no such opinion.

Accordingly, it is clear from the record in this case that petitioners have failed to demonstrate either that Hridhay suffered a "Table Injury" or that Hridhay's injuries were "actually caused" by a vaccination. **Thus, this case is dismissed for insufficient proof. The Clerk shall enter judgment accordingly.**²

²The undersigned notes that if petitioner elects to file a Petition for Fees and Costs pursuant to § 300aa-15(e), based on current case law petitioner will need to first establish proof of vaccination and the timely filing of the Petition for Vaccine Compensation, see § 300aa-16(a)(2) and 16(b), prior to any award for attorneys' fees and costs being granted. See Brice v. Secretary of Health and Human Services, 358 F.3d 865, 869 (Fed. Cir. 2004), citing Martin v. Secretary of Health and Human Services, 62 F.3d 1403, 1406 (Fed. Cir. 1995).
