ATTORNEYS' FEES AND COSTS DECISION¹

On June 21, 2005, petitioners filed a claim for compensation on behalf of their son, Terry, in the National Vaccine Injury Compensation Program ("the Program"). The undersigned issued a decision in this case on April 19, 2011.

On October 17, 2011, respondent file a stipulation of facts concerning attorneys' fees and costs. Petitioners are entitled to reasonable attorneys' fees and costs pursuant to §§ 15(b) and (e)(1). Petitioners seek attorneys' fees and costs in the amount of \$4,331.55, in the form of a check payable to petitioners and petitioners'

attorney, William M. Graham.² This amount represents a sum to which respondent does not object.

The undersigned approves the requested amount for attorneys' fees and costs as reasonable. Accordingly, an award should be made in the form of a check payable jointly to petitioners and petitioners' attorney, William M. Graham, Wallace & Graham, P.A, in the amount of \$4,331.55.³ In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.⁴

² In lieu of a statement from petitioner that complies with General Order No. 9, petitioners' counsel has represented that he will reimburse petitioner for any personal litigation costs compensable under the Vaccine Act from the award of attorneys' fees and costs in this case.

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See generally Beck v. Sec'y of Dep't Health and Human Services, 924 F.2d 1029 (Fed. Cir.1991).

⁴ Pursuant to Vaccine Rule 11(a), entry of judgment is expedited by the parties' joint filing of notice renouncing the right to seek review.
