Petitioner Yung Jen Kuo filed an application for attorneys' fees and costs on December 16, 2010. The Court awards the amount to which respondent has not objected.

Petitioner claimed that the influenza vaccine caused an adverse reaction and received compensation based upon the parties' stipulation. Decision, filed November 12, 2010. Because petitioner received compensation, he is entitled to an award of attorneys' fees and costs. 42 U.S.C. § 300aa-15(e).

Petitioner seeks a total of **\$19,708.85** in attorneys' fees and costs for petitioner's counsel. Additionally, petitioner filed a statement of costs in compliance with General Order No. 9,

stating that he incurred no litigation expenses while pursuing this claim. Respondent stated that she had no objection to this application for attorneys' fees and costs.

After reviewing the request, the court awards **\$19,708.85** in attorneys' fees and other litigation costs. The court thanks the parties for their cooperative efforts in resolving this matter.

The Clerk shall enter judgment accordingly.²
