DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On December 2, 2010, the parties filed the attached stipulation, in which they agreed to settle the attorneys' fees and costs in this case and described the settlement terms. Petitioner requests **\$7,000.00** for attorneys' fees and costs in this case. In accordance with the General

Order #9 requirements, petitioner states that no costs were incurred to pursue this petition. The court finds the amount requested by petitioner to be reasonable.

The court hereby adopts the parties' said stipulation, attached hereto, and awards compensation in the amount and on the terms set forth therein. Pursuant to the stipulation, the court awards a total of **\$7,000.00**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of one check made jointly payable to petitioner and William Dobreff, Esq., in the amount of **\$7,000.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
