DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On December 7, 2010, petitioner filed a verified petition for fees and expenses. Petitioner requests **\$7,250.54** in attorneys' fees and costs. In accordance with the General Order #9 requirements, petitioner states she incurred **\$1,800.00** in costs to pursue her petition. Respondent has agreed not to object to the amount requested by petitioner. The court finds the amount requested by petitioner to be reasonable.

L. No. 107-347, 116 Stat. 2899, 2913 (Dec. 17, 2002). Vaccine Rule 18(b) states that all decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would constitute a clearly unwarranted invasion of privacy. When such a decision is filed, petitioner has 14 days to identify and move to delete such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall delete such material from public access.

The court hereby adopts the verified petition, attached hereto, and awards compensation in the amount and on the terms set forth therein. Pursuant to the stipulation, the court awards a total of **\$9,050.54**, representing reimbursement for **\$7,250.54** in attorneys' fees and costs and **\$1,800.00** in petitioner's costs. The award shall be in the form of:

- (a) a check made jointly payable to petitioner and David P. Murphy & Associates, P.C. in the amount of **\$7,250.54**; and
- (b) a check made solely payable to petitioner in the amount of **\$1,800.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²

VERIFIED PETITION FOR FEES AND EXPENSES

Comes now David P. Murphy, who being first duly sworn upon his oath deposes and says:

1. That he is an Attorney at Law duly admitted to practice before the Supreme Court of Indiana, the United States District Court for the Southern District of Indiana and the United States Supreme Court.
2. That he maintains an office at 504 West Main Street, Greenfield, Indiana 46140 and his office telephone number is 317-462-2222.
3. That he is counsel of record for the Petitioner herein, Nancy Ferguson.
4. That he has been representing the Petitioner continuously since September, 2008; that those legal services were billed at an hourly rate of \$200 per hour.
