DECISION ON ATTORNEY FEES AND COSTS¹

Vowell, Special Master:

In this case under the National Vaccine Injury Compensation Program,² I issued a decision denying entitlement and dismissing this case on March 30, 2012. On April 25, 2012, petitioner filed an unopposed motion for attorney fees and costs. Petitioner has separately filed an accounting of his attorney's hours and expenses and a statement pursuant to General Order #9 setting forth his personal litigation costs. The motion indicates that respondent does not object to the requested amount.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and (e)(1). Further, the proposed amount seems

reasonable and appropriate. **Accordingly, I hereby award the total \$3,457.10³ as follows:**

- **a lump sum of \$2,757.10 in the form of a check payable jointly to petitioner, Kevin M. Hinnefeld, and petitioner’s counsel of record, David P. Murphy, for petitioner’s attorney fees and costs, and**
- **a lump sum of \$700.00 in the form of a check payable to petitioner, Kevin M. Hinnefeld, for his personal litigation costs.**

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the clerk of the court shall enter judgment in accordance herewith.⁴

IT IS SO ORDERED.

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, “advanced costs” as well as fees for legal services rendered. Furthermore, 42 U.S.C. § 300aa-15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See *generally Beck v. Sec’y, HHS*, 924 F.2d 1029 (Fed. Cir.1991).
