**DECISION ON ATTORNEY FEES AND COSTS<sup>1</sup>**

**Vowell**, Special Master:

In this case under the National Vaccine Injury Compensation Program,<sup>2</sup> I issued a decision adopting the parties' joint stipulation settling this case on May 15, 2012. On May 29, 2012, petitioner filed an application for legal fees. The application indicates that respondent has no objection to the requested amount.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and (e)(1). Further, the proposed amount seems reasonable and appropriate. **Accordingly, I hereby award the total \$7,288.65<sup>3</sup> as follows:**

This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, 42 U.S.C. § 300aa-15(e)(3) prevents an attorney from charging or collecting fees (including

- a lump sum of \$6,938.65 in the form of a check payable jointly to petitioner, Pamela Kwiatkowski, and petitioner's counsel of record, Peter Sarda, for petitioner's attorney fees and costs, and
- a lump sum of \$350.00 in the form of a check payable to petitioner, Pamela Kwiatkowski, for her personal litigation costs.

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the clerk of the court shall enter judgment in accordance herewith.<sup>4</sup>
